INTERNATIONAL NURSING DAY 2022



The International Nursing Day 2022 was held face-to-face this time, in the heart of Brussels. It set the start of an annual tradition for celebrating this day in Brussels each year on the same date - May 12th. This time, we also formally launched the programme for the 'Decade of the specialist nurse 2020-2030' campaign. It was welcomed by a number of European organisations, with the presence of Maya Mathews, head on Unit for Performance of National Health Systems, DG Sante and emphasising on the future role of the Specialist Nurse in the health environment and stressing the relevance of the recognition and tackling the urgent matter of nurse shortage.

During the last General Assembly, the programme of ESNO 'Decade of the specialist Nurse 2020-2030'was adopted and will continue to be a mile stone for specialist nurses in Europe. ESNO SURVEYS – urgent request

Vaccination and Nursing Roles, Responsibilities Education and Uptake

"Follow up on vaccination survey 2020: ESNO Survey to Nurses in Europe Nursing and Vaccination: uptake, roles, education, and responsibilities.

If you are working as a nurse in Europe, we would like to invite you to participate in the ESNO Survey to Nurses in Europe on Vaccination Uptake (2022). This is a follow-up study to the 'ESNO Survey to Nurses in Europe on Vaccination Uptake' conducted in November 2020. The ESNO 2020 survey has already produced important findings, but much has happened in the past two years during the COVID-19 pandemic.

The aim of the survey is to gain insights into the roles, positions, knowledge, and education of nurses in Europe regarding vaccination. The data from 2020 and 2022 will be compared and submitted for publication in peer-reviewed journal(s). This approach will enable us to share our expertise and knowledge with the right platforms and provide solid evidence to inform policymaking about the role of nurses with vaccination in Europe.

The current survey (2022) is an extension of the previous survey (2020) about vaccination uptake, including new items on nurses' roles, engagement, and responsibilities regarding vaccination. The survey focuses on vaccines in general and, more specifically, on influenza and COVID-19 vaccinations. Our ambition is to conduct the survey every two years.

The participation of as many respondents as possible is essential to ensure that the knowledge, beliefs, and responsibilities of nurses are accurately presented. To reach said goal, the survey is available in eight languages: English, Dutch, German, French, Spanish, Polish, Greek and Italian.

Survey on Medication Errors

The cause of this is strongly related to stress at the workplace, lack of sleep, complex medication systems, and an overload of administration. Because of this, we are composing a survey on medication errors, with a special focus on nurse's experiences. After all, often the nurses seems to get the blame and are secondary victims of great impact health errors. We also wonder if this situation has a correlation with the <u>A new</u> directive on work-life balance

- Under the European Commission activities, there are a series of program
 related to the Health Workforce. The Health Workforce Projects Cluster
 covers five EU co-funded projects under the umbrella of the 3rd Health
 Programme. The projects focus on three key topics medical deserts,
 task shifting and retention policies that will be investigated thoroughly
 and internationally in the coming years. ESNO is in strong relation with
 the programs to support this in the expertise and dissemination, with a
 specific relation with METEOR and TASHI.

- ESNO welcomes the announced 'European Health Union: A European Health Data Space for people and science' taking the lead in tomorrow's world for the health professionals 'Thanks to the EHDS, people will have immediate, and direct access to the data in electronic form, free of charge. They can easily share these data with other health professionals in and across Member States to improve healthcare delivery. Citizens will be in full control of their data and will be able to add information, rectify wrong data, restrict access to others and obtain information on how their data is used and for which purpose.'

For the ESNO it is relevant to know what the implications will be for the Specialist Nurses, and also what their responsibilities will be. For this, a special webinar will be initiated after the summer.
